This executive summary of the School Accountability Report Card (SARC) is intended to provide parents and community members with a quick snapshot of school accountability. About This School

Central Valley Training Center, Inc. (CVTC) is a specialized school contracting with Manteca USD, Stockton USD, and Lodi USD, providing functional skills training to students with disabilities age 18-22 and grades 12+ focusing on transition. CVTC provides an Extended School Year instructing 250 days out of the year for students who are not on the diploma track. Functional skill focus is on Self Advocacy, Community Integration and Vocational Training. Teacher supervised instruction is provided in small group setting with one instructor/aid for every three students. Students spend a minimum of 51% of their time, on average, out of the school facility participating in teaching sessions such as bus riding, purchasing skills, social skills, community participation, volunteer work and paid work. The school facility is 5000 square feet plus a fenced in yard, amenities include a kitchen, computers, multiple handicap accessible restrooms, and 8 classrooms available for small group functional skills instruction. Students attending CVTC are integrated into groups with adults participating in the functional skills program licensed by the State of California and funded by California Regional Centers.

CVTC Mission

"We support people in achieving their potential."

CVTC is a specialized school contracting with Manteca USD, Lodi USD and Stockton USD, providing functional skills training to students with disabilities age 18-22 and grades 12+ , not wishing to receive a diploma and focusing on transition in Stockton, CA. CVTC provides an Extended School Year instructing 250 days out of the year. Functional skill focus is on Self Advocacy, Community Integration and Vocational Training. Teacher supervised instruction is provided in small group setting with one instructor/aid for every three students. Students spend a minimum of 51% of their time, on average, out of the school facility participating in teaching sessions such as bus riding, purchasing skills, social skills, community participation, volunteer work and paid work. Young adult students have the opportunity to be hired at local businesses or perform paid work in small group settings. CVTC provides students the supervised opportunity to participate in Special Olympics, working out at the local In Shape Health club, dances and the opportunity to try out for theatrical productions. Students attending CVTC are integrated into groups with adults participating in the functional skills program licensed by the State of California and funded by California Regional Centers.

CVTC remodeled the training and instructional areas of the school in 2008. The school facility is 5000 square feet plus a fenced in yard, amenities include a kitchen, computers, multiple handicap accessible restrooms, and 8 classrooms available for small group functional skills instruction. Classrooms have a casual seating area along with round tables and four chairs for small group instruction at a 1:3 ratio. One classroom has been converted to a "sensory" room with specialized fixtures, and activities. This classroom functions as a sensory room at designated times according to the lesson plan. Lockers are available for students to keep personal belongings. The manicured grounds include a fenced in activity area, paved and fenced in parking area for busses, surrounded by sidewalks, benches, grass and trees. Restroom facilities include two male and female specific and one unisex. An area for changing of non-ambulatory students is also available.

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities (SD) and English language learners (ELL) is reported based on three levels (identified, excluded, and assessed). Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
